Notice Inviting Tender

The High Commission of India Lusaka invites competitive bids from experienced fire drill/extinguisher company for supply of 32 fire extinguishers and 12 fire blankets (1.8meter x 1.2meter each) for High Commission of India properties i.e. Chancery at Pandit Nehru Road (Chancery), Kabulonga (India House) and other three residential properties at Joseph Mwilwa Road/Makishi Road. The agency shall deploy experienced and knowledgeable personnel for the installation of the fire extinguishers at the properties as per requirements of the High Commission.

2. The scope of work includes supply of 32 newly-filled 9.0KG Dry Chemical Powder Fire Extinguishers (as per following) & installation of same:-

3. The scope of work also includes supply of 12 sealed pack high quality fire-proof blankets. The scope of work also includes regular half-yearly filling of these 32 extinguishers as well as old 23 fire extinguishers available at High Commission of India properties and the servicing of three 30 meters fire hose reels with pressure check. The rates must exclude VAT.

4. The company must be able to provide services on the credit basis whenever required.

6. Sealed bid must contain a quotation mentioning the rates (amounts in Kwacha) for above mentioned scope of work excluding VAT. The envelope should be submitted with superscription of company name, "Bid for fire equipment at the High Commission of India Lusaka properties" for the 'Head of Chancery, High Commission of India, Lusaka' latest by December 14, 2022 before 1600 hrs. The rate quoted should be valid for a period of one year at least. The bids received shall be opened on December 14, 2022 at 16:00 hrs.
