Subject: Revision of fee for Passport, Visa, OCI and other Consular services w.e.f. 1/4/2022.

As per Ministry's directions conveyed vide JS (CPV)'s communication No. VI/401/01/14/2019 dated 25/3/2021, all the consular fee in terms of local currency is to be revised w.e.f. 1st April every year @ ORE for the month of April that year. The mid-year revision is still to be done upward on devaluation of local currency against US Dollar by 10% or more. Similarly, the fee in terms of local currency may be revised downward, if the value of local currency appreciates against US Dollar by 15% or more with prior approval of the Ministry.

2. The ORE for the month of April 2022 has been conveyed i.e. US\$1=Rs.76.83 & Rs.1=ZMW0.2304. By the aforementioned ORE the conversion of US\$ into ZMW is **US\$1=ZMW17.70**. It may be noted that in terms of Official Rate of Exchange (ORE), the Zambian Kwacha has appreciated by 19.45% against US Dollar since April 2021 (US\$1=ZMW21.975), however, **the fee has to be revised as per Ministry's directions w.e.f. 1st April every year independent of appreciation or depreciation in value of the local currency.**

3. In view of above, we have calculated the various CPV services' fee and ICWF based on the above ORE for April 2022 as mentioned above. The charts (Annexure -I, II & III), showing the proposed revised Passport & Consular services, OCI and Visa fee respectively, are placed below for perusal/approval.

4. If approved, the fee schedules will be uploaded on the Mission's website and Consular Notice Board of the Mission.
