The High Commission of India, Lusaka invites competitive bids from experienced water pump maintenance companies/agencies based in Lusaka for Annual Maintenance Contract (AMC) for maintenance of twelve water pumps installed at its premises i.e. Chancery premises, India House and other three residential properties at Makishi Road and Joseph Mwilwa Road.
